What is the Critical Energy Infrastructure (CEI) Hub?

- Stores 90% of all liquid fuels used throughout the state (gas, diesel, oil), 100% of jet fuel, and more than 150 chemicals used by Oregon companies; houses an electrical substation, pipelines, RR lines, docks.
- Houses more than 600 above-ground storage tanks; over 400 tanks are in active use.
- Contains more than 350 million gallons of fuels and chemicals (530 Olympic-sized swimming pools).
- Spans 200 acres, along a 6-mile stretch of land between the Willamette River and Hwy 30 in north Portland.
- Owned and operated by ten private corporations.



UUs say Hands Off! in Hillsboro

Many members of the Unitarian Universalist Community Church of Washington County (UUCCWC) participated in the April 5th Hands Off Rally at the Hillsboro Civic Center. An estimated 1,500 people attended the peaceful demonstration, representing a number of nonprofit groups. Hillsboro's mayor, Beach Pace, and U.S. House of Representative Suzanne Bonamici were among the speakers. Participants marched legally on neighborhood sidewalks at the end of the rally. Some members and friends attended Portland, Beaverton, and Forest Grove rallies as well. Hillsboro area residents returned to the same Civic Center location and block sidewalks on May Day.

Plans are underway for a June 14th No Kings Day rally in Hillsboro and other area locations.

Green Upgrades and Sustainability at UU Fellowship in Klamath Falls

The Unitarian Universalist Fellowship of Klamath Falls is in full swing. We are lay-led and for the past few months have had an intern minister, Eli Poore, who led one service a month in their rotation with SOUUP (Southern Oregon UU Partnership).

Almost two years ago, we moved into our new Fellowship building which used to be the Grocery Pub and we have renamed the PUUB (Place of UU Beauty). We have replaced the old oil furnace and made numerous upgrades as part of our efforts to prioritize environmentally sound practices and promote sustainability as we engage in the Green Sanctuary 2030 process. We are partnering with Sustainable Klamath at the upcoming Migratory Bird Day Festival and will be sponsoring a gathering at the Fellowship where community members can learn from representatives of the Oregon Energy Trust on how to access free or low-cost insulation and windows to increase their energy efficiency.

In addition to climate and environmental justice, our Fellowship is prioritizing food security in our community and we are a robust part of the Interfaith Food Pantry. We are celebrating our first year as a pantry where four congregations partnered and pooled their resources to create a pantry that nourishes folks both spiritually and nutritionally. We recognize the importance of centering love and a narrative of solidarity, not charity. In addition to food, we distribute toiletries, blankets, sleeping bags and also bicycles.
