As the training proceeds, your group will be given time to identify power brokers in your area and to think about how to communicate with them to bring about change. You will be asked to have a flip chart with post it notes or a whiteboard for your group to share their ideas.

Social Justice News from the UU Church in Eugene:



Hands Off Protest: UU Church of Eugene members and other Eugene citizens showed up strong for the April 5 Hands Off protest.

An estimated 3,500 people gathered to speak up for justice and protection for civil servants, government programs, trans folks, immigrants, and more!

The church's social action thermometer is now nearly full, which reflects the members' engagement in the wider community. A celebration will be scheduled in the near future. Reason for feeling proud indeed!

Refugee and Immigrant Support Group.

The group has attended training on how to respond to ICE and has provided more than 50 binders with information on "Know Your Rights" for people at risk, including 10 families who participate in our twice a month Produce Plus program.

Indigenous Connections Team. The Indigenous Connections Team will soon post a land acknowledgment at UUCE. This winter the team hosted a movie and discussion at UUCE about missing indigenous women. The team is also coordinating with an interfaith group for other activities, including Poetry in the Park on May 5.

Earth Justice Group: The UUCE Earth Justice Group is organizing a rally for Earth Day, April 20, on the two streets next to the church, to raise awareness that our "Blue Boat Home" needs our help and protection!



Power in Coalitions

UUUC Roseburg's Social Action & Justice Committee has joined actively with Indivisible, Shades of Blue, the Democratic Party, and other organizations to work toward a safer, saner, and better-informed community in our very red county. We have hosted sign-making workshops in our activity room and participated in four different stand ups for a variety of issues, including Veterans at our local VA, Social Security, Support for Ukraine, and others in our Stand on the Side of Love.

The Umpqua UU Congregation continues staffing, serving on the Board, and collecting donations of food and money for the Fish Food Pantry as they have for over 25 years. The website and Facebook pages below give a broader picture of the Fish of Roseburg Food Pantry.

Care for the Incarcerated Program at UU Fellowship of Central Oregon

UUFCO has a newly created group that is investigating ways to increase humanitarian conditions at the Deschutes County jail, with the goal of reducing recidivism. The group is rapidly growing as church members learn about the initiative. The group is currently examining the scope of the problem they want to address, beginning with identifying support services during and after incarceration. Some of these services focus on housing.

The group met recently with the County Commissioner in an effort to gather information about current conditions. They learned that a number of existing rules created during COVID no longer seem relevant. The practices appear to be designed more for the benefit of administrators than for people who are incarcerated. More information will be forthcoming as the group continues it work.

News from Our Congregational Liaisons

UU Fellowship of Central Oregon is seeing a lot of energy around a coalition that is forming to protest actions of the federal government. Five liberal ministers called a meeting this week, expecting 50-100 people to come. Instead, more than 300 showed up.

UU of Grants Pass reported that, in reaction to the Supreme court ruling on homeless camps, a lawsuit was filed, challenging the city's treatment of people with disabilities who are homeless.

The church is providing support for a permanent center that is supporting homeless services.

UU Church in Eugene created a Direct Action email list designed to alert people to upcoming events and to provide a forum for people to discuss issues. One fourth of the members of the congregation signed on, which meant determining how to facilitate communication without overwhelming people with emails. Two months after its initiation, the Direct Action email list is going to be divided into two lists, to become more manageable. The Direct Action title will be retained for alerts and notifications of bills, protests, and meetings that call for action. The second email list will be developed for discussions and sharing information and articles.

Wy'East UU Congregation celebrated Trans Day of visibility early. They held a potluck picnic in a park on Sunday, March 31st. It was very well attended.

UU Fellowship of Corvallis is providing "Know Your Rights" brochures from the Civil Liberties Defense Center. They are available at the Democracy Action Team's table on Sundays. UUFC also will host a program by Corvallis Palestine Solidarity on May 1; it will include reports by Corvallis residents who have recently visited Gaza.

Katarina Jones joins ORUUVfJ board

We are welcoming another new Board Member! Katarina Jones will be such a joy to have aboard. She has been in Grants Pass and active there in Justice issues. She has lived in several areas of the state, and is presently in Portland to attend Portland State University.
